This form is intended for San Diego Regional SO participants, parents, volunteers, proctors and guests attending San Diego Regional tournament on March 4, 2023 at San Diego Miramar College. Signature of Parent/Guardian (if participant or attendee is under 18 years of age on date of signing) **OR** Signature of Participant or Attendee (if at or over 18 years of age on date of signing) is required.

### Assumption of Risk and Release of Liability

#### Assumption of Risk

I, and/or participant, understand and acknowledge that my child's and/or my participation and/or entrance to the event and related areas may involve serious risks, including but not limited to risk of property damage, bodily injury, permanent disability, paralysis and death. These risks may result from the participation and/or entrance to the event and related areas, the acts of others, or the unavailability of emergency medical care or immediate response. I, and/or participant, knowingly and freely assume all such risks, and assume full responsibility for my child's and/or my participation in the event and/or entrance to the event and related areas.

#### Release of Liability

I, and/or participant, hereby completely release, indemnify, hold harmless and forever discharge the San Diego Regional SO, its directors, officers, agents and volunteers from and against any liability or responsibility for any property damage, property loss, property theft, personal injury, death, claim, or any damage of any kind, whether arising from the alleged negligence of the San Diego Regional SO, its directors, officers, agents and volunteers or otherwise, which may arise out of or relate in any way to my child's and/or my participation and/or entrance to the event and related areas. I agree to be solely responsible for any medical, health or personal injury costs relating to my child's and/or my participation in the event and/or entrance to the event and related areas. I also understand and agree that this release shall be binding as against my heirs and assigns.

### Use of Media and Digital Content and Release of Liability

When participants, parents, volunteers, proctors and guests (collectively "you") enter event premises and related areas, you enter an area where photography, audio and video recording may occur.

By entering the event premises and related areas, you consent to photography, audio recording, video recording and its/their release, publication, exhibition or reproduction to be used for promotional purposes, Awards ceremonies or any other purpose as determined by the San Diego Regional SO and its officers and directors.

By entering the event premises and related areas, you release San Diego Regional SO, its directors, officers, agents and volunteers and all persons involved from any liability connected with the taking, recording, digitizing or publication and use of photographs, images, video and/or sound recordings for any purpose including but not limited to Awards ceremonies, advertising and promotion of future events.

By entering the event premises and related areas, you waive all rights you may have to any claims for payment or royalties in connection with any use, regardless of the purpose. You also waive any right to inspect or approve any photo, image, video, or audio taken by the event organizers or any persons affiliated with and/or authorized by the San Diego Regional SO, its directors, officers, agents and volunteers.
